Additional Fees to be paid locally, if required:

- * Additional Driver Fee: Each additional driver is approx. EUR 39.00, per rental, VAT included, paid locally.
- * Young driver surcharge: Drivers age 21 - 24 are required to pay approximately EUR 37.13, per day (maximum EUR 445.54), VAT included, paid locally.
- * GPS: Approximately EUR 19.00, per day, VAT included, paid locally or approximately EUR 89.70, per week, VAT included, paid locally (5-7 days). One way rental restrictions and fees may apply.
- * Infant Seats: Approximately EUR 46.00, per rental, VAT included, paid locally. Available for children 0 - 13kg.
- * Booster Seats: Approximately EUR 13.16, per rental, VAT included, paid locally. Available for children 22kg and up.
- * Child Seats: Approximately EUR 46.05, per rental, VAT included, paid locally. Available for children 0 - 25kg.

This is an important notice to make your car rental a smooth experience.

In order to provide you with the most transparent information on the price of your car rental services, we have listed on your voucher what the price paid to Kemwel includes and what it does not include. Terms and conditions vary by country, so we have listed any local fees that you might be liable to pay to the car rental company at time of vehicle collection. These are the only mandatory fees or services you are required to pay locally to the car rental company.

The actual car rental company listed on your voucher might give you the option to purchase equipment (such as GPS unit, child safety seat, ...) , prepaid tank of gas or additional insurances. Unless they are listed as mandatory on your voucher, these items are optional and you may choose to purchase them or not. If you are unsure or require further information, you should contact us at time of vehicle pickup on our toll free number, 24 hours a day, on the number listed below (see Terms and Conditions section). Kemwel cannot accept liability for items purchased locally.

At time of pickup, we also strongly recommend that you check that the condition of the vehicle is adequately reflected on the rental agreement and that any pre-existing damage is indicated. Should you expect to be delayed for the pickup of the vehicle, you should also contact us to ensure your vehicle can be confirmed after the scheduled timing.

It is also your responsibility to be aware of the local driving laws and local tolls or stickers required for any country you are traveling into. Again, you can call Kemwel on our free toll number at any time for advice and assistance.

Finally, we strongly recommend that you request and review a copy of the rental agreement in English, wherever the car rental company can produce one.

We wish you safe travels and hope you enjoy your car rental.

Terms and Conditions

Kemwel has arranged your rental with the car rental company shown on the voucher after your payment of the services. Kemwel is independent, not an agent for any particular car rental company. This voucher confirms your reservation with the rental company. The voucher is not a rental agreement. When you pick up the vehicle, you must sign a rental agreement provided by the rental company and subject to local laws. Kemwel cannot be held responsible if you do not meet the car rental company's requirements to rent a vehicle, or if you do not have available all the necessary documentation. Additional fees may apply for rental service beyond hours of operation. All car rates are guaranteed in US Dollars, all local fees are billed in local currency.

Kemwel does not provide insurance. Coverage is provided by the rental company as indicated. Additional coverage may be available for purchase from the rental company. Insurance does not provide coverage for damage to windows, wheels, tires, roof, underside or interior of the vehicle.

- * The local supplier will require a security deposit to be blocked on the primary drivers credit card for the duration of the rental. Contact Kemwel for exceptions. Drivers license must be held for a minimum of 2 years (some exceptions may apply).
- * The same credit card that was used to pay for the vehicle MUST be presented at the rental counter upon pick up. An International Drivers license is strongly recommended. Kemwel can help you obtain one.
- * All non French residents must present a valid passport at time of pick up in addition to the drivers license.
- * Optional items (ie: luggage rack, child seats, etc.) are on a request basis only, for an additional fee.
- * Drop off charges, if applicable, are estimates only, and may change without notice.
- * Reservations may be extended without penalty by contacting Kemwel before the expiration of the rental period.
- * A cancellation fee equal to 3 days rental charge will apply if reservation is cancelled within 3 days of pick up and there will be no refunds in the event of cancellation after the scheduled date and time of pick up.
- * There will be no refund for unused days.
- * Deliveries/Collections are available on a request basis only, for an additional fee.
- * The rental invoice may only show the balance due on delivery. This assures that you will not pay unnecessary surcharges.
- * Minimum driver age 21.
- * Additional drivers sign on and pay locally.
- * Cars are not permitted to travel into Eastern Europe or any African country (i.e. Morocco, Algeria, Tunisia, etc.).
- * When traveling to Germany, the vehicle requires an environmental emission sticker. Please check with the car rental company at time of pick up.
- * When travel is permitted outside the renting country it is the responsibility of the renter to make sure their vehicle complies with the local laws of the country in which they are travelling, this includes but is not limited to safety equipment, cross border documents, toll stickers etc. Vehicles may not travel on ferries and/or to Island locations without pre-approval from Kemwel.
- * All rentals are based on 24 hour periods with a 3 day minimum rental, a full day is charged for any portion of a day that the vehicle is used.
- * 5, 6 & 7 day rentals constitute a weekly rate, any rental duration longer or shorter than 5-7 days is calculated on a daily basis.
- * Kemwel strongly advises client to check if car is DIESEL or REGULAR GASOLINE at pick up.
- * While you can use a debit card to pay for your reservations through Kemwel, cash deposits, Maestro, Switch, Visa Electron, pre-paid credit cards and debit cards are rarely accepted locally, so please be sure to check with our agents at time of reservation if you require this facility.
- * If driving the vehicle into Germany, winter tires may be required. It is the responsibility of the client to check local laws and request equipment as necessary.
- * Rentals commencing in July and August, there will be no refunds for any vans, with pick up anywhere in Europe, once confirmed with payment and no refunds for any unused rental days.
